QUESTIONS & ANSWERS

Question How long time will the Annual General Meeting take?

Answer The Annual General Meeting is expected to take 1-1½ hour.

Question What will be served at the Annual General Meeting?

Answer There will be served coffee, tea, water and cookies.

Question Who can attend the Annual General Meeting?

Answer Both Shareholders whose shares are registered by name and shareholders whose

shares are not registered by name can attend the Annual General Meeting. However, for shareholders whose shares are not registered by name issuance of admission cards requires that a deposit slip not more than five days old issued by VP Securitites A/S or by the accounting banker (the place of deposit) is forwarded to the Company as documentation of the shareholding. The deposit slip must be accompanied by a written declaration stating that the share has or will not be sold

before the Annual General Meeting has been held.

Question How many attendants can each shareholder bring?

Answer Each shareholder (VP account number) can bring one attendant. If the shareholder has given proxy to a third party to attend on his/her behalf this

person can also bring an attendant.

Question When shall a share be acquired at the latest in order for the shareholder

to attend the Annual General Meeting?

Answer The share must be acquired at latest 5 days prior to the Annual General Meeting

(and the shareholder must still own it on the day of the Annual General Meeting).

Question Who can vote at the Annual General Meeting?

Answer Holders of A shares registered by name at the time of the notice convening the

Annual General Meeting can vote. Also the holders of A shares who has notified and documented his/her acquisition to the Company at the time of the notice convening the Annual General Meeting (30 March 2010) can vote. B shares carry

no votes.

Question I have an A share, but it is not registered by name. If I arrange for my

share to be registered by name now will I then obtain a right to vote?

Answer No, the share must be registered by name at the time of the notice convening the

Annual General Meeting (30 March 2010) to carry vote.

Question My shares are not registered by name, can I still attend the Annual

General Meeting?

Answer Yes, shareholders whose shares are not registered by name can attend. However, issuance of admission cards requires that a deposit slip not more than five days old issued by VP Securities A/S or by the accounting banker (the place of deposit) is forwarded to the company as documentation of the shareholding. The

deposit slip must be accompanied by a written declaration stating that the share

has or will not be sold before the Annual General Meeting has been held.

Question Where is my VP account number/password stated?

The VP account number and password are stated in the invitation sent to the shareholders of shares registered by name. If the shareholder has changed the password it will not appear in the invitation and the Company has no possibility for providing it. However, a new password can be provided via the Shareholder Portal and will be sent to the shareholder by regular mail unless an email address

has been stated earlier on.

Question Who has received an invitation to the Annual General Meeting?

Answer

Invitations have been sent to all shareholders whose shares are registered by name.

Question

How can I order an admission card?

Answer

Shareholders whose shares are registered by name can order admission cards either via the Shareholder Portal by use of the VP account number and password or print the request form on the Company's webpage and send it to the company either by regular mail or by email. Admission cards can also be ordered by phone. Shareholders whose shares are not registered by name can order admission cards by printing the request form on the Company's webpage and send it to the Company either by regular mail, by email or by phone. Furthermore, shareholders whose shares are not registered by name must forward a certified deposit slip not more than five days old issued by VP Securitites A/S or by the accounting banker (the place of deposit) to the Company as documentation of the shareholding. The deposit slip must be accompanied by a written declaration stating that the share has or will not be sold before the Annual General Meeting has been held.

Question My shares are registered with my company as owner. How shall I order admission card?

Answer

The admission card shall be ordered in the name of the company but you should mention the name of the person that will be representing your company. The person representing your company is allowed to bring an attendant.

Question How can I give proxy to a third party to represent me at the Annual General Meeting?

Answer

The shareholder can fill in the relevant proxy form which can be found both on the Shareholder Portal and on the Company's webpage. Only shareholders of A shares can give proxy to vote. Remember to state the address whereto the admission card shall be sent.

Question I have seen the notice convening the Annual General Meeting in the newspaper, why haven't I received an invitation?

Answer Probably because you are holder of shares that are not registered in your name.

Question How can I have my shares registered by name?

Answer

Only your bank can register your shares by name. Upon such registration by your bank, the Company will receive information hereof and change the Company's share register accordingly.

Question I am on vacation can you send the admission card to my temporary address?

Answer

The admission card will be sent to the address stated in the share register. If the shareholder wishes to have it sent to another address, this address shall be stated when ordering the admission card.

Question I have shares in both my company's name and my own name, how many persons can attend the Annual General Meeting?

Answer

The company holding shares can attend by being represented by a person. This person can bring an attendant. Also the person holding his own shares can attend and bring an attendant.

Question Why is the lower part of my admission card blank (the voting paper)?

Answer

This is either because 1) your shares are B shares, 2) you have acquired your shares after the time of the notice convening the Annual General Meeting or 3) your shares are A shares but you have granted proxy to the Board of Directors.

Question The attendant I planned to bring with me to the Annual General Meeting is prevented from coming, can I bring someone else?

Answer Yes, as long as the Company is informed. For security reasons it is important that the correct name is registered with the Company.

Question What happens if I do not receive my admission card in due time?

Answer We will strive to send out the admission card in good time. If you unfortunately

should not receive your admission card in due time, we will be able to check that

you have registered to attend the Annual General Meeting at the entrance.

Question How do I find Bella Center?

Bus (Line 30) goes from the Copenhagen Central Station and stops at Bella **Answer**

> Center (Auditoriebygningen) and at Bella Center Station (East entrance). Bus Line 4A is going from Svanemøllen Station via Valby Station and Sjælør Station to Sundbyvester Plads and back which stops at Bella Center (Auditoriebygningen) and Bella Center Station (East entrance). Metro Line M1 is going from Vanløse to Vestamager. Metrostation Bella Center is located by Bella Center Each entrance.

Exit 19 from highway E20 is very close to Bella Center.

Question How are the parking possibilities at Bella Center?

There is a big parking area at Bella Center and the parking fee is paid by the Answer

Company. We advise you to show up in good time since it can take some time to

walk from the parking area to the entrance.

Is Bella Center equipped for handicapped in wheel chairs? Question

Yes, Bella Center is a very handicap friendly place. Answer
