## A.P. Møller - Mærsk A/S announces offering of ordinary shares in Total S.A.

Today, Maersk Oil Trading and Investments A/S ("**MOTI**"), a wholly-owned subsidiary of A.P. Møller - Mærsk A/S, announces that it has decided and launched today a sale (the "**Placing**") of its ordinary shares in Total S.A. ("**Total**"), a company listed on Euronext Paris, to institutional investors with final terms to be determined through an accelerated bookbuilding process.

The Placing comprises an offering of 17,272,593 existing ordinary shares corresponding to the entire stake currently held directly by MOTI in Total.

The book building is commencing immediately and MOTI reserves the right to close the books at any time. MOTI will announce the outcome of the Placing upon its completion. MOTI expects to hold no shares in Total following the divestment. Barclays Bank PLC and Citigroup Global Markets Ltd. have been appointed by MOTI to act as Joint Global Coordinators and Bookrunners for the Placing.
