# Corporate governance statement 2024

Cf. section 107b of the Danish Financial Statements Act

This statutory corporate governance statement for A.P. Møller - Mærsk A/S (also referred to as the company) covers the accounting period 1 January to 31 December 2024 and is prepared pursuant to section 107b (1) and (3) of the Danish Financial Statements Act. The statement forms part of the Management review of the Annual Report for 2024. This statement includes the status of compliance with the 'Recommendations for Corporate Governance' issued by the Danish Committee on Corporate Governance December 2020 and implemented by Nasdaq Copenhagen in the Rules for issuers of shares ('Regler for udstedere af aktier').

The statement is based on a 'comply-or-explain' principle. For some of the recommendations the company complies partly (recommendation 1.1.2, 1.3.1, 3.1.5, 3.3.2, 3.4.2, 3.4.4, 3.5.2). An explanation why the company has chosen to comply partly with a recommendation and what it has chosen to do instead, has been made where relevant.
